

Graduate School, Khon Kaen University Announcement (No. 129/2023)

On Conditions and Guidelines for Requesting Restoration of Student Status

To ensure that the process of student status restoration proceeded smoothly, by virtue of Section 40 of Khon Kaen University Act B.E. 2558 and the Regulations of Khon Kaen University on Graduate Education Level, B.E. 2566 Article 66 Requesting Restoration of Student Status. Adhere to the agreement of the Committee Board of Graduate School Meeting at 8/2023 on August 3, 2023, has therefore issued the conditions and guidelines for requesting restoration of student status as follows:

Clause 1 This announcement shall be called "Graduate School, Khon Kaen University Announcement (No. 129/2023) on Conditions and Guidelines for Requesting Restoration of Student Status"

Clause 2 This announcement is effective from the issued date onwards.

Clause 3 The previous Graduate School, Khon Kaen University Announcement (No. 32/2017) on Conditions and Guidelines for Requesting Restoration of Student Status is no longer applied.

Clause 4 The qualifications of those eligible to apply for the restoration of student status are as follows:

- 4.1The student status was terminated according to the Regulations of Khon Kaen University on Graduate Education Level, B.E. 2566 Article 65.3 and 65.4.
- 4.2 In the case of studying in a program plan/type that includes coursework and has a cumulative grade point average (GPAX), the GPAX must not be less than 3.00 before the student's status was terminated.

4.3 Received approval from the Program Administrative Committee and the

Faculty that the program is affiliated with.

Clause 5 The restoration of student status can be made once. The person wishing

to restore the status must submit a request to the faculty with which the program is

affiliated at least 3 weeks prior to the beginning of the semester.

Clause 6 The calculation of the study duration includes the time before termination,

the period of termination, and the time after the restoration of student status.

The total duration should not exceed the specified period as mentioned in the regulations

in Article 10 above.

Clause 7 To count credit hours, all evaluated credits shall be counted.

For courses that have not been assessed, students need to re-register for those courses.

Clause 8 Regarding student status restoration fees, those who have granted

approval for the restoration must pay for the fees as well as the fees collected per

semester in accordance with Khon Kaen University's Regulations.

Clause 9 The Dean of the Graduate School shall be in charge of this announcement.

In case the principles or guidelines are not defined, or if any dispute arises from this

announcement, the Dean of the Graduate School has the final authority regarding

arbitration, and his/her decision is final.
